Insurance Requirements  
For Leasing/Rental of Equipment**

To Whom It May Concern:

Prior to the release of any equipment by Milestone Equipment Company, LLC (MEC) as agent for Milestone Chassis Company, LLC ("MCC") in accordance with our lease provisions, you are required to provide a Certificate of Insurance certifying that the following insurance policies are currently maintained by your company:

1. Any Auto or Hired Auto Commercial Automobile Liability insurance with a minimum of \$1,000,000 per occurrence combined single limit. **MEC & MCC & CSC & MTL, and each of its other subsidiaries must be named as an Additional Insured under this policy;**
2. Commercial General Liability insurance in the minimum amount of \$1,000,000 per occurrence. **MEC & MCC & CSC & MTL, and each of its other subsidiaries must be named as an Additional Insured under this policy;**
3. "All Risk" Physical Damage insurance in an amount at least equal to the replacement value of the equipment on lease/rental. **MEC & MCC & CSC & MTL, and each of its other subsidiaries must be named as Loss Payees under this policy OR Trailer Interchange insurance in a minimum amount of \$27,000 per unit;**
4. Workers' Compensation insurance, or similar type coverage, in compliance with applicable State Laws;
5. The Certificate must provide MEC with thirty-day (30) guaranteed cancellation clause, wherein we will be advised prior to cancellation or material change in the required policies. **The Certificate must indicate that MEC & MCC & CSC & MTL, and each of its other subsidiaries are named as Additional Insured's and Loss payees, As Their Interests May Appear (ATIMA) on the aforementioned policies of insurance (except for Workers' Compensation).**
